New Aetna & AmeriHealth Reports Now Available!

Aetna Report Highlights:

- Gaps in care with payer claims through May 31, 2025
- Internal data through June 25, 2025
- First Aetna report set for 2025!

Note: Aetna uses a rolling 12-month view, so current results may reflect both 2024 and 2025 activity. Targets shown are from 2024 and will be updated once 2025 benchmarks are available.

AmeriHealth Report Highlights:

- Gaps in care with payer claims through May 31, 2025
- Internal data through June 24, 2025
- Now using updated 2025 targets for reporting and projections

Note: Prior AmeriHealth reports used 2024 targets.

Highmark Commercial Report Highlights:

- Gaps in care with payer claims through May 31, 2025
- Internal data through June 25, 2025
- Files are available in the Highmark folder (raw data) and the Downloads folder (KidWell format) on the SFTP

Important Notes:

2025 targets are not yet available—2024 targets are being used as placeholders

This report is not yet aligned with expected contract measures

BMI is missing; we are working with Highmark to include it in future reports

Report includes Combo 10 and Depression Screening, which are not part of 2025 contract measures and may be disregarded

Combo 10 was replaced by Combo 7, which is identical except that it excludes the flu vaccine

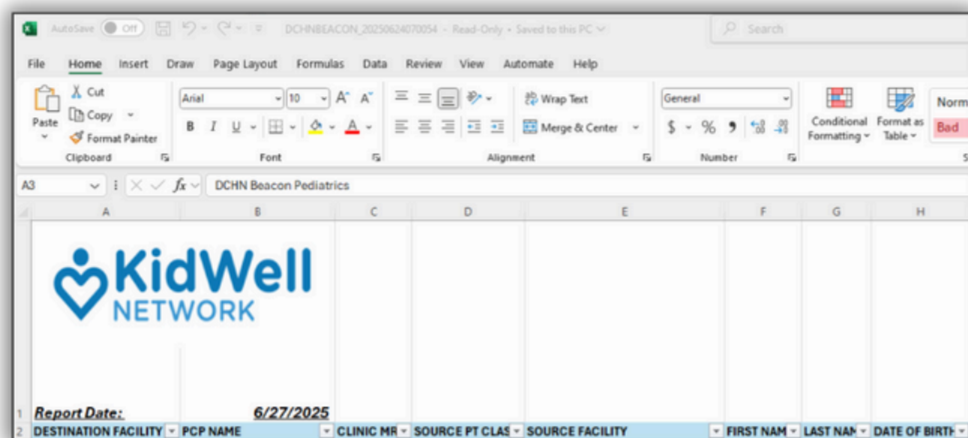


ED Utilization Report – Enhanced Format Sneak Peek!

We're excited to share a sneak peek of the newly KidWell-branded and enhanced DHIN ED Utilization Report—designed to make patient follow-up faster, clearer, and more actionable.

What's New:

- Streamlined layout with KidWell branding
- Easier-to-read format for real-time follow-up
- Same reliable daily report—just enhanced!



What It Is:

A daily feed of patients seen in the ED within the past 24 hours, based on your submitted rosters. It includes limited admission diagnosis data and is meant to support immediate outreach per your practice workflows.

Reminders:

- Patients may appear multiple times (e.g., admitted, discharged, or revisits)
- Based on rosters your practice submits to the Nemours Data Team for DHIN alerts

KidWell Resource Updates:

Epinephrine Nasal Spray (Neffy)

Neffy offers a needle-free epinephrine option for treating type 1 allergic reactions, including anaphylaxis, in patients ≥ 4 years old and ≥ 15 kg.

It may be especially helpful for needle-averse patients or school/daycare settings.

Recommended Dosage:



| Recommended Dosage ¹ | |
|---------------------------------|--------------------------------|
| Patient's Weight | Dosage |
| 30 kg or greater | One spray of neffy 2 mg |
| 15 kg to less than 30 kg | One spray of neffy 1 mg |

Note: If needed after 5 minutes, administer a second spray in the same nostril

Key Notes:

- No contraindications, but caution in patients with nasal structural abnormalities (e.g., polyps, fractures).
- May alter nasal mucosa for up to 2 weeks, possibly affecting other nasal medications.
- Tested in allergic rhinitis, but not in patients with more complex nasal conditions.

Coverage & Cost:

- Not on DE/PA/MD Medicaid preferred lists (may require a coupon and still carry higher out-of-pocket costs).
- Commercial insurance: Often covered, \$25 copay with manufacturer card.
- Cash price: \$800–\$1,000
- GoodRx Members: Around \$200
- Patient Assistance Available for those who qualify (\$0)
