Flu Mist: Two Approved Options for Administration

As of now, there are two approved ways to receive FluMist:

In-Person Administration

By a healthcare provider in a clinical setting or pharmacy

At-Home Use (Approved Fall 2024)

Self-administered or caregiver-administered

Looking ahead: AstraZeneca plans to offer home delivery for self-administration starting with the 2025–2026 flu season.



Ordering FluMist is easy

When you place your online order, you'll complete a brief medical questionnaire, provide insurance information, select a delivery date, and provide shipping payment. A pharmacist will review the information you provided to make sure FluMist is right for you and everyone you're ordering for. Then, FluMist will be delivered to your home, ready for you to administer. It's really that simple!

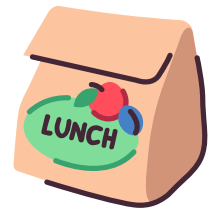
